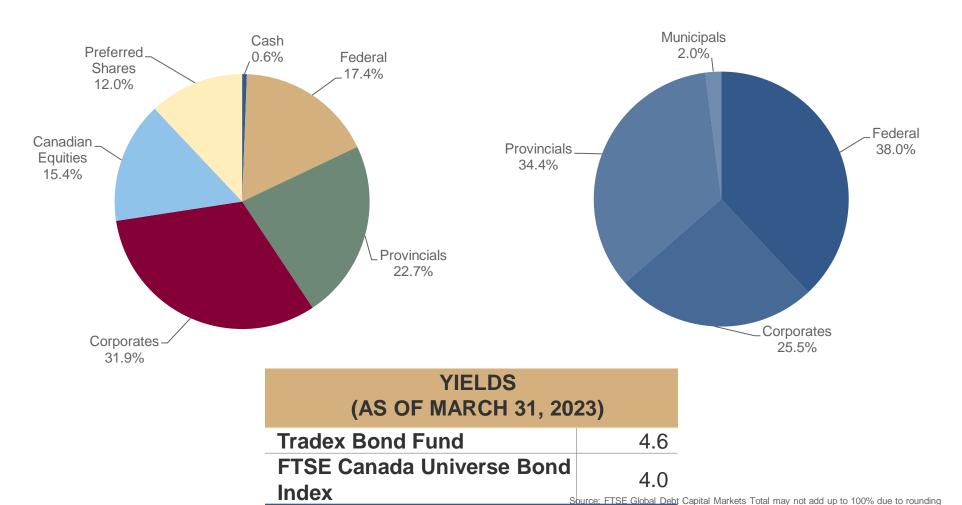

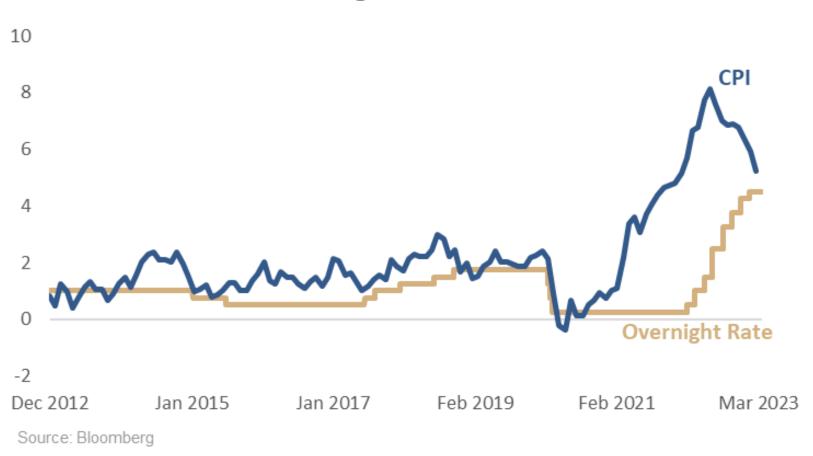

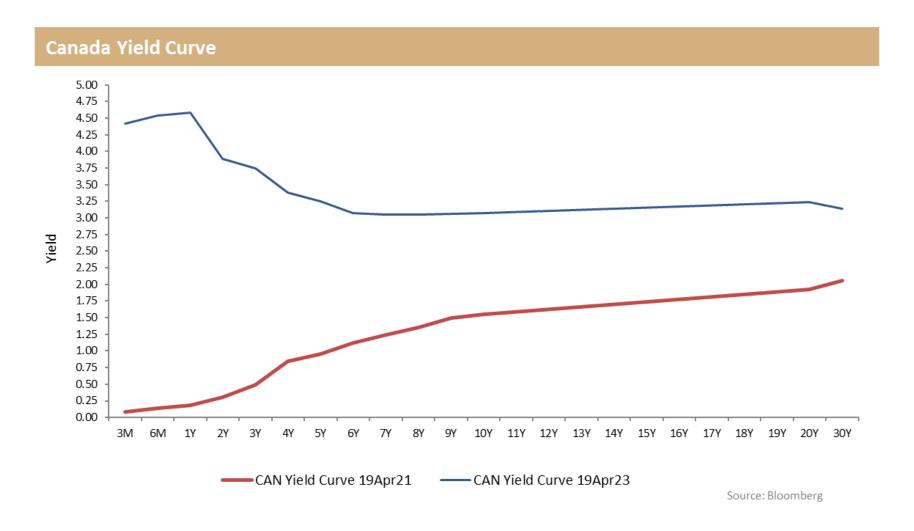


Overnight Rate vs CPI

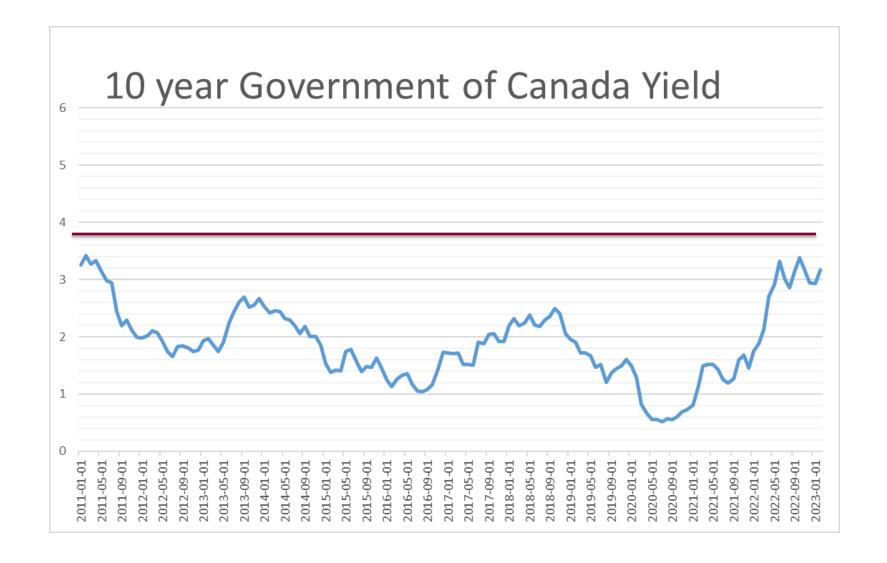


GOVERNMENT OF CANADA YIELD CURVE



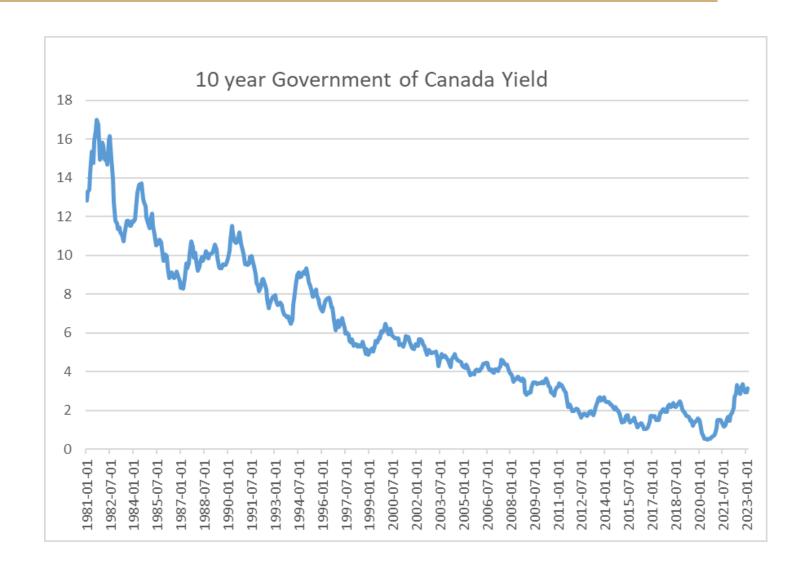

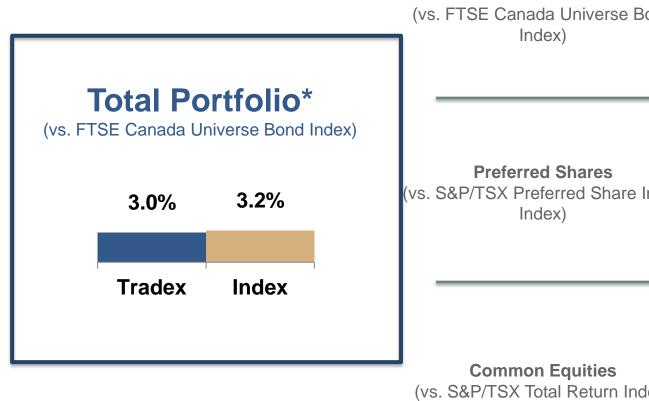

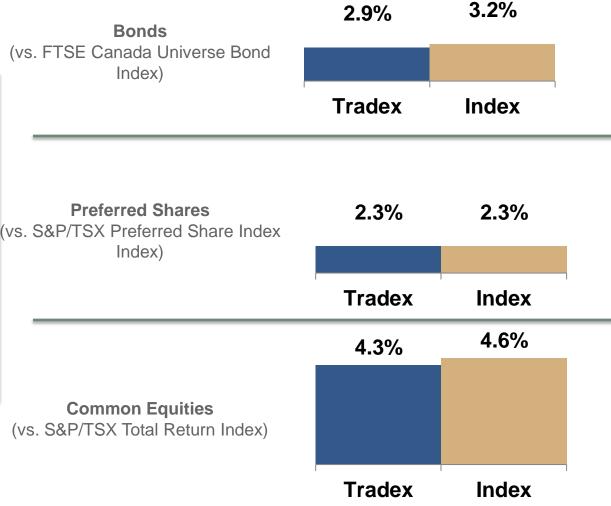

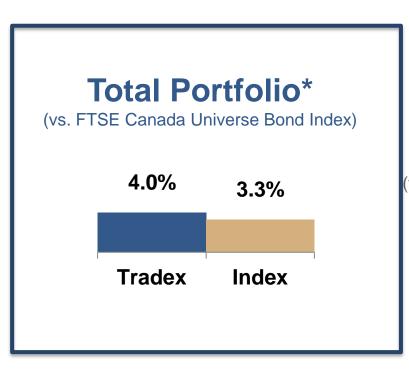


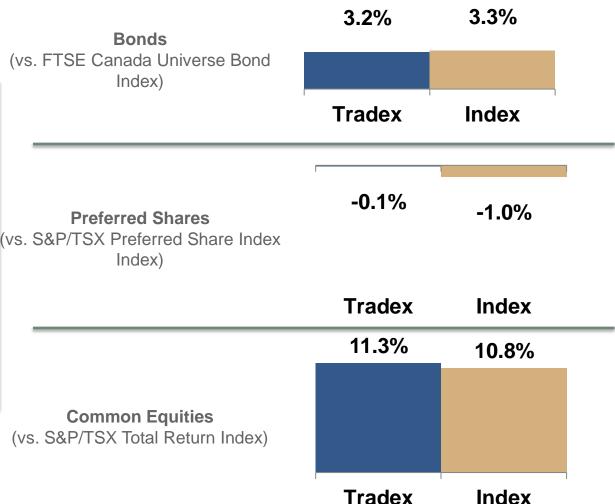

PORTFOLIO PERFORMANCE - 6 MONTH





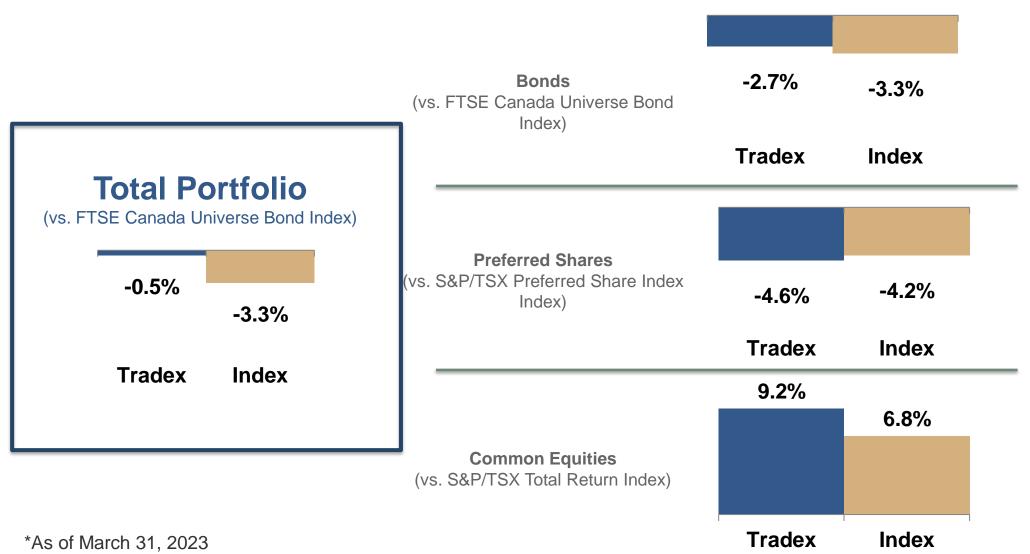

PORTFOLIO PERFORMANCE - 2 YEAR



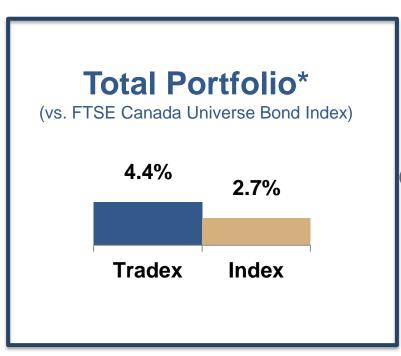

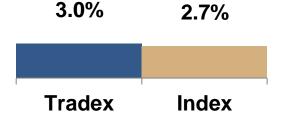

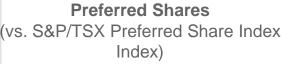
PORTFOLIO PERFORMANCE – FGP MANDATE
